The RECTOR PREAMBLE

CONSIDERING that the University of Rome “Tor Vergata” is interested in commercializing the national and/or international patent applications and/or patents listed in the attachment A;

CONSIDERING that the University with this Notice is inviting Companies to submit an Expression of interest in undertaking commercial negotiations regarding the above mentioned national and/or international patent applications and/or patents, according to the economical conditions that will be determined in said negotiations;

CONSIDERING that, among the Companies that submit an Expression of interest for the national and/or international patent applications and/or patents listed in the attachment A, the University will choose the company that during the negotiations presents the economically most advantageous offer for the University;

Public and private entities that meet the requirements of art. 1 of this notice to send an Expression of interest in undertaking commercial negotiations, addressed to the Head Office of the University of Rome "Tor Vergata", located in Rome, Via Cracovia n. 50.

Art. 1 Eligible Subjects

Applicants are professionals, individuals engaged in business, companies of people who operate a business, business associations under the form of joint-stock companies with limited liability or limited partnerships (Italian form of business association: “Società di capitali”), consortia of companies and other entities consortium, cooperative societies, public research institutes and private foundations, public companies and government agencies, established in Italy and/or the rest of the world that carry out industrial activities and/or research in the fields of the above mentioned industrial inventions (attachment A).

Art. 2 Procedures

The expression of interest, in accordance with the procedures indicated in art. 3 in this Notice, must arrive at the University no later than 12:00 pm on the 27th of each month. In the event that the 27th of the month is a holiday, the first working day after the holiday will be considered as expiration date.

After receiving the expressions of interest and request, the University will proceed to send the documents to the Commission for the Promotion of Research results and Technology Transfer (CVRTT) that will verify the correctness of the documents submitted, and the eligibility requirements provided. The CVRTT will draw up a list of expressions of interest and will start a commercial negotiation for each expression of interest.

Art. 3

Procedures for the submission of expressions of interest

The expression of interest must be submitted writing, in a sealed envelope which can either be sent by registered post or delivered in person to the following address:

The envelope must bear the name of the sender and the following wording:

Avviso pubblico per una manifestazione d’interesse ad avviare una trattativa commerciale inerente la domanda di brevetto con indicazione del titolo di cui all’allegato A (“Public call for Expression of interest to start commercial negotiations regarding the patent application entitled...; see Attachment A”).

The envelope must contain the expression of interest of the public or private entity willing to participate in the commercial negotiations concerning one or more patents.

In charge of the procedure is Ms. Loredana Pastore - Dir. II – Div. III – Rip. I (Brevetti e licensing > *Patent & Licensing Office*).

Art. 4

Content of the expressions of interest and related documentation

The proposing company must submit the Expression of interest in simple form attaching a photocopy of an identity card of the signer in accordance with D.P.R. nr. 445/2000 and subsequent modifications and supplements.

In addition, must include the following elements, which can then be verified by the University:

- For individuals:

a) personal data of the applicant;

- b) fiscal code;
- c) declarations stating: to enjoy civil and political rights; not have any obstacles with regard to the current anti-mafia legislation; not have criminal convictions that determine the inability to contract with the government, in accordance with the applicable standards;
- d) a brief report indicating the field of activities, and the reasons why you believe you are interested in the use of the patent.

- For companies, corporations and government agencies:

- a) company name, registered office, fiscal code, VAT number, details of the person having the powers of representation of shareholders and if in partnership with the related powers;
 - b) a Declaration of registration in *registro unico delle imprese* (Italian register of Business associations) at the competent Chamber of Commerce or other entity corresponding for the non-Italian companies, with the following information: registration number, legal form of business association, name of firm, registered office and type of activity, personal details and titles of all legal representatives; Italian fiscal code and VAT number, number of employees on the date of submission of the Expression of interest.
 - c) A Declaration, under penalty of exclusion, signed by the legal representative in which he/she declares under his/her own responsibility that the proposing company complies with the requirements stated by the article 80 of D.Lgs. nr. 50/2016 and subsequent modifications and supplements;
 - d) a brief description of the activity performed by the organization and its affinity with the exploitation of the patent;
- For foreigner participants it is requested that the above statements are documented according to the rules of equivalence.

Art. 5
Additional information

In accordance with the Law, the University of Rome "Tor Vergata" reserves the rights to annul or draw back this Notice and/or to interrupt the selection procedure and/or the commercial negotiations.

Entities that have expressed interest in starting a business negotiation inherent in the patent application mentioning the title of Attachment "A" may be required to provide any other information, news and documentation.

The University of Rome "Tor Vergata" promptly publish on its website any notes or clarifications of general interest in order to participate in the selection.

Art. 6
Processing of personal data

The University of Rome "Tor Vergata" carries out processing operations on the personal data provided by the proponent, in accordance with the provisions of EU Regulation 2016/679 ("GDPR") and the Italian legislation of reference on data protection of personal
